

MOBILE VIDEO TAPES d/b/a KRGV-TV5, and d/b/a KRGV-DT, its subsidiaries and affiliated companies (together, the "Company"), will conduct the Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **Description of Contest/Participation:** KRGV will award ten (10) randomly selected winners a Mathes Satellite antenna and installation package beginning January 4, 2018 in celebration of the launch of 5.2. Somos El Valle. The winners will be awarded an antenna and installation for two televisions on external walls of their home. One winner will be selected each week for 10 weeks.

A. **Dates of Contest:** The Contest will begin on December 26, 2017, and end March 12, 2018. All entries must be received no later than 9:00AM Central Standard Time on March 12, 2018.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of entrants.

2. **Winning the Contest.** The winners will be selected in a random drawing from among all eligible entries received. One winner will be announced each week during CHANNEL 5 NEWS at Noon over a 10-week period. The first winner will be announced on January 8, 2018 and the final winner will be announced March 12, 2018. Odds of winning depend on the number of the eligible entries received.

Winners will be contacted by KRGV with instructions how to claim their prize. Winners will get in contact with Mathes Satellite to make arrangements for installation. KRGV will notify Mathes Satellite of the winners.

Winners who live a greater distance than 50 miles from the KRGV tower in La Feria, TX may incur additional fees for antenna and installation service.

3. **Eligibility and Limitations.** Entrants and winners must be U.S. residents at least 18 years old (as of December 26, 2017) as determined by the Company, and must reside in Hidalgo, Cameron, Willacy or Starr, County, Texas. Only one (1) entry per person. Employees of the Company, the Contest's participating sponsors and their advertising agencies, members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.
